

Work Notice

The mission of DTSC is to protect California's people and environment from harmful effects of toxic substances through the restoration of contaminated resources, enforcement, regulation and pollution prevention.

UC Richmond Field Station and Campus Bay (Zeneca) Field work beginning October 7, 2013

Why This Notice?

The Department of Toxic Substances Control (DTSC) is distributing this work notice to inform the community about DTSC approved work located at the UC Richmond Site and the former Zeneca (Campus Bay) property.

What Work Will Be Done?

Campus Bay (Zeneca): Semi-annual groundwater monitoring will be done at the Site. This involves taking groundwater levels and collecting groundwater samples for analysis. This sampling is conducted twice per year to monitor site conditions. The work will begin on October 7 and last until October 18th. All work will be completed during normal business hours (8:00 AM to 5:00), Monday through Friday. Residents should expect to see a drill rig and truck and workers in protective gear

UC Richmond Field Station: Also beginning October 7 groundwater level measurements will be taken from wells located at the Richmond Field Station Site. Installation of 5 groundwater monitoring wells at the UC Richmond Field Station Site will occur beginning on October 16th and take approximately 3 days to complete. The wells will be installed upgradient and downgradient of the Biologically Active Permeable Barrier (BAPB). After the wells are installed they will be developed the following week. It is expected to take 2 days to do this. Then the next week, the wells will be sampled. This is expected to take 1 day. All work will be completed during normal business hours (8:00 AM to 5:00). The community should expect to see a drill rig, support trucks and workers in protective equipment doing the work.
