## Campus Bay Lot 3 (Zeneca) 1415 South 47th Street, Richmond, CA

### Field Work Beginning November 20, 2013

The Department of Toxic Substances Control (DTSC) will oversee maintenance activities of the temporary cap located on Lot 3 of the Zeneca property. The temporary cap is comprised of HydroSeal II, a natural, biodegradable cellulose mix that is mixed with water, and sprayed on the ground surface. The purpose of the HydroSeal II is to form a physical barrier that acts as a ground cover to limit dust generation and exposure to the ground surface.

### What Work Will Be Done?

This work will include spraying the weeds with a pre-emergent herbicide (Glyphosate Pro 4) and Telar XP (pre- and post-emergent herbicide). The herbicides will be applied by registered applicators according to the label instructions. This work is to be conducted the week of November 18th. During the week of December 2nd, Kuma Corp. will be applying HydroSeal to portions of the temporary cap where damage or significant weathering has been observed..

All work will be completed during normal business hours **(8:00AM to 5:00PM), Monday through Friday**. Residents should expect to see:

- Trucks with herbicide and HydroSeal II
- Workers in protective gear

This work is part of the annual maintenance that is required for the temporary cap.

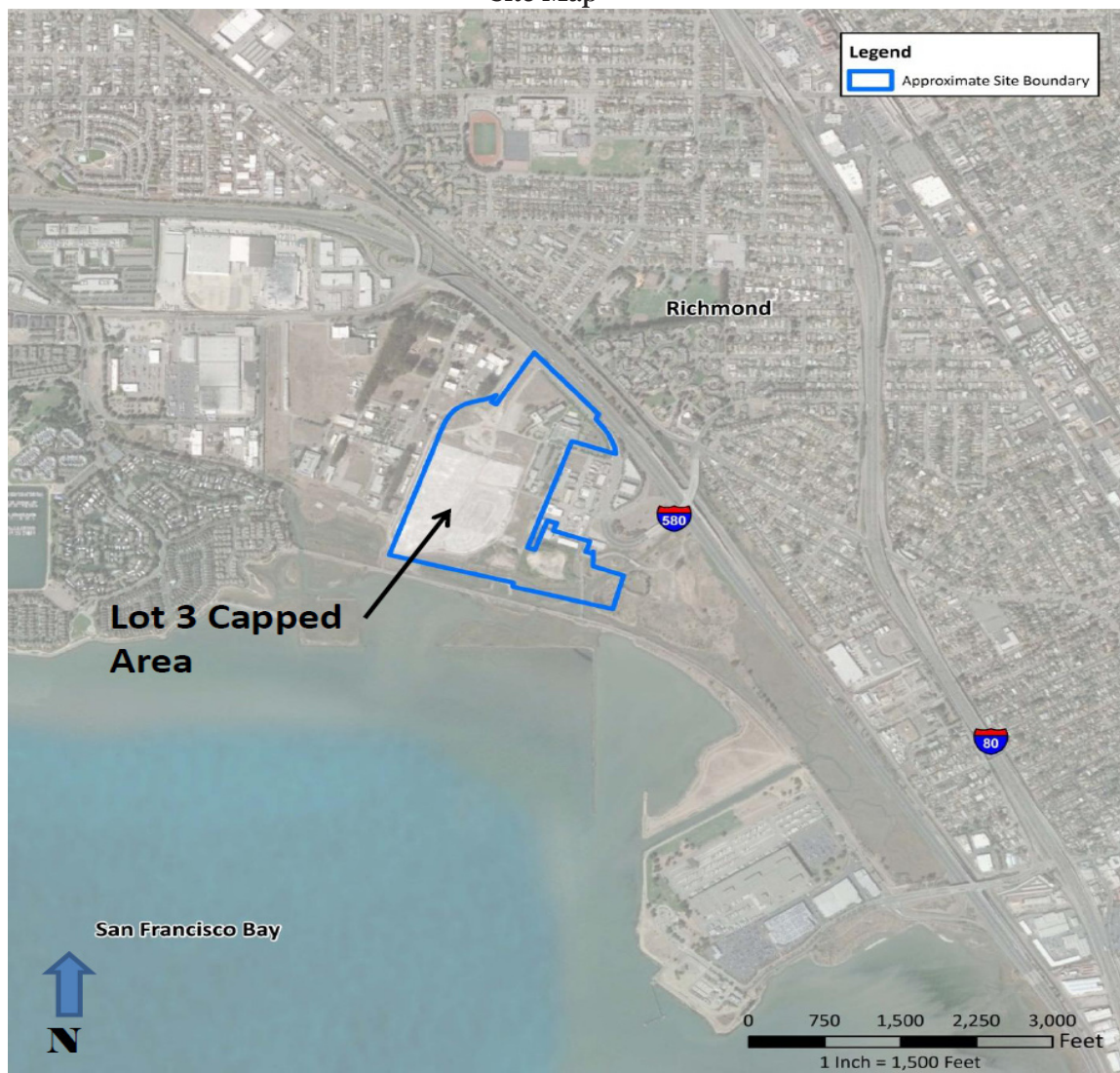
