The mission of DTSC is to protect California's people and environment from harmful effects of toxic substances through the restoration of contaminated resources, enforcement, regulation and pollution prevention.

Campus Bay Lot 3 (Zeneca) Maintenance Work Beginning May 15

The Department of Toxic Substances Control (DTSC) will oversee maintenance activities of the temporary cap located on Lot 3 of the Zeneca property. The temporary cap is comprised of HydroSeal II, a natural, biodegradable cellulose product that is mixed with water, and sprayed on the ground surface. The HydroSeal II forms a physical barrier limiting dust and exposure to the ground surface. There are currently weeds growing in some areas of the cap. DTSC has approved work to apply an herbicide for weed control and to conduct maintenance on the temporary cap from May 15 to May 26, 2017. Gardener's Guild will be doing this work.

What Work Will Be Done?

Vegetation located on the temporary cap will first be trimmed, using hand-held powered equipment and potentially by hand-pulling or hand tools. Then, the pre-emergent herbicide Glyphosate Pro 4 and pre- and post-emergent herbicide Telar XP. will be applied where needed by registered applicators from Gardener's Guild according to label instructions. The herbicides will be applied only to weeds growing on the temporary cap located on Lot 3. Care will be taken to prevent the herbicides from drifting beyond the temporary cap area. Application will not be done on days of high winds (defined as over 15 miles per hour with gusts). Workers will wear personal protective equipment in accordance with the manufacturer's directions. Work is expected to begin on the week of May 15th. All work will be completed during normal business hours (8:00 AM to 5:00 PM), Monday through Friday.

Residents should expect to see:

- A 200 gallon tank on a trailer towed by a pick-up truck, or in the bed of a pick-up truck.
- There could be two trucks operating at any one time.
- Gardener's Guild Workers wearing protective gear.
- Workers spraying the herbicide from hoses that are attached to the tanks.
