UNIVERSITY OF CALIFORNIA, BERKELEY RICHMOND FIELD STATION MONTHLY SUMMARY REPORT

DECEMBER 15, 2011

This monthly summary report (MSR) summarizes environmental site investigation and remediation activities conducted on behalf of The Regents of the University of California (UC) at the University of California, Berkeley's Richmond Field Station in accordance with Section 6.3 of the California Environmental Protection Agency, Department of Toxic Substances Control (DTSC) Site Investigation and Remediation Order (Order), Docket No. I/SE-RAO 06/07-004, effective on September 20, 2006.

- a. Specific actions taken by or on behalf of Respondents during the previous calendar month (November 2011).
 - UC Berkeley completed the implementation of the Final Technical Memorandum for Well
 Destructions submitted to DTSC on August 19, 2011, to close several existing research wells
 that are no longer needed.
 - UC Berkeley submitted a draft Radiological Survey and Sampling Plan (RSSP) for approval in November 2011 to the California Department of Health Services Radiological Health Branch for decontamination and decommissioning (D&D) of Buildings 102 and 110.
 - UC Berkeley conducted a jurisdictional wetlands delineation at the restored marsh area on November 21, 2011. The wetland delineation was completed as requested by the U.S. Army Corps of Engineers (USACE) at the October 13, 2011 on-site meeting to verify completion of conditions of USACE Clean Water Act, Section 404, Nationwide Permit (NWP) 38 #28135S issued for the 2002-2004 remediation and restoration in Western Stege Marsh.
- b. Actions expected to be undertaken during the current calendar month (December 2011).
 - On December 9, 2011, UC Berkeley submitted the final revised Phase I Groundwater April 2011 Sampling Results Technical, dated August 19, 2011, including a response to comments to DTSC's November 18, 2011 comment letter.
 - UC Berkeley will submit a wetlands delineation report to USACE, DTSC, and the U.S. Fish and Wildlife Service as requested by USACE at the October 13, 2011 agencies meeting.
- c. All planned activities for the next month (January 2012).
 - Depending on the receipt of Phase II sampling data and the ability to schedule planning
 meetings with DTSC staff, UC Berkeley tentatively anticipates submitting a draft Phase III
 Field Sampling Workplan to continue to assess soil in portions of previously-identified data
 gap areas of the RFS by the end of January 2012.
 - UC Berkeley will submit a Draft Phase I October 2011 Groundwater Sampling Results Technical Memorandum by January 10, 2012.
 - UC Berkeley will submit a Draft Phase II Field Sampling Workplan Sampling Results Technical Memorandum by January 20, 2011.
 - UC Berkeley will submit a Draft Well Closure Documentation Report by January 20, 2011.

d. Any requirements under the Order that were not completed.

 - Completion of implementation of the Field Sampling Workplan and other tasks is dependent on the ability to meet with DTSC staff on a timely basis and may require adjusting schedules and extensions of deadlines.
