UNIVERSITY OF CALIFORNIA, BERKELEY RICHMOND BAY CAMPUS RICHMOND FIELD STATION SITE MONTHLY SUMMARY REPORT February 20, 2025

This monthly summary report (MSR) summarizes environmental site investigation and remediation activities conducted on behalf of The Regents of the University of California (UC) at the University of California, Berkeley's Richmond Field Station Site in accordance with Section 6.3 of the California Environmental Protection Agency, Department of Toxic Substances Control (DTSC) Site Investigation and Remediation Order (Order), Docket No. I/SE-RAO 06/07-004, effective on September 20, 2006.

- a. Specific actions taken by or on behalf of Respondents during the previous calendar month (January 2025).
 - <u>Reporting and Communication: Quarterly Meetings.</u> UC Berkeley staff conduct quarterly meetings with DTSC to provide DTSC, EPA, City of Richmond, Campus Bay, and UC Berkeley Richmond Field Station representatives with the opportunity to coordinate together on regional cleanup activities at the southeast Richmond shoreline. All parties met on January 9. DTSC requested a follow-up meeting with UC Berkeley Richmond Field Station and Campus Bay representatives to resolve issues concerning DTSC's request for a joint groundwater monitoring program, but a meeting date was not set.

b. Actions expected to be conducted during the current calendar month (February 2025).

• <u>Reporting and Communication: Corp Yard Investigation, East Meadow and DU7.</u> UC Berkeley submitted a summary letter presenting sampling results for the East Meadow and DU7 excavation to DTSC and EPA on March 15, 2024. DTSC provided comments dated May 10, 2024, to UC Berkeley on June 5, 2024; EPA stated on June 27, 2024, that it had no comments. UC Berkeley provided a verbal response in the quarterly meeting with DTSC on October 10, 2024. UC Berkeley proposed potholing to collect step-out samples starting from the excavation sidewalls and bottoms that exceeded the cleanup level and stated it would follow up with DTSC to provide work plan details. UC Berkeley provided a revised summary letter to address DTSC comments on February 7, 2025.

c. All planned activities for the next month and beyond (February 2025 and beyond).

- <u>Reporting and Communications: Natural Opens Space Feasibility Study/Remedial Action</u> <u>Plan (NOS FS/RAP).</u> UC Berkeley is preparing the NOS FS/RAP to address the proposed remedy for the NOS. UC Berkeley will conduct a report review meeting with DTSC prior to the submittal of the document.
- <u>Reporting and Communication: Western Transition Area (WTA) Phase V Investigation.</u> UC Berkeley will respond to agency comments on the summary report submitted on October 10, 2024.
- <u>Reporting and Communication: Quarterly Meetings.</u> UC Berkeley staff conduct quarterly meetings with DTSC. The purpose of these meetings is to provide DTSC, EPA, City of Richmond, Campus Bay, and UC Berkeley Richmond Field Station representatives with the opportunity to coordinate together on regional cleanup activities at the southeast Richmond shoreline. The next meeting is scheduled for April 10, 2025.

- <u>Reporting and Communications: Soil Management Plan.</u> Per discussions with DTSC on April 11, 2024, UC Berkeley will prepare the Draft Soil Management Plan, Revision 4, following completion of the 5-Year Review, as the updated screening levels would require documentation within the Soil Management Plan. Revision 4 will replace the Draft Soil Management Plan, Revision 3, which was not finalized.
- <u>Reporting and Communication: B112 PCB Removal Action.</u> UC Berkeley will issue hard copies of the final implementation summary report for the B112 Transformer Area PCB removal action to DTSC.
